

Terms and Conditions and Privacy Policy for Receiving Text Messages from the Professional Women of Color Network

1. Acceptance of Terms and Conditions

By providing your mobile phone number and opting in to receive text messages from the Professional Women of Color Network ("PWOCN"), you acknowledge and agree to the following Terms and Conditions and Privacy Policy.
